- **Movere - Microsoft**

Movere is a software-as-a-service solution (SaaS) product, for discovery and assessment of your IT landscape, which was acquired by Microsoft, and it's no longer sold as a standalone solution. Movere is available through the Microsoft Solution Assessment Program.

Movere automates discovery, scanning, and collection of IT data within your organization. You can analyze collected data to learn about your infrastructure, devices, and apps, make smart decisions, and facilitate migration to the cloud.

- Movere and Block 64 tenants used to run the Solution Assessment are based in the West Europe Azure Region. Azure Migrate tenants can be created in any Azure region that the customer selects.
CloudPilot and CSAT assessment tools do not create a tenant for the scope
- Deliverables for your Solution Assessment are created in a Windows Virtual Desktop, which is hosted in the West Europe Azure Region
- Solution Assessment Technical Analysts, an additional highly technical skilled role, may access your Solution Assessment outcome for providing you with additional information and deeper analysis and insights. Technical Analysts may reside outside Europe, but nothing will be stored locally on their laptops or in any other storage device outside Europe, as they will exclusively operate for that matter through the West Europe based Windows Virtual Desktop environment
- Final deliverables will be stored in a specific Solution Assessment Sharepoint site, which is hosted in the West Europe Region and the PowerBI deliverables, when used, are hosted on Microsoft Azure in West Europe Region
